
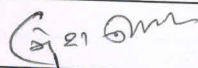

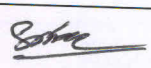
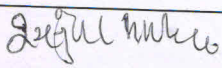
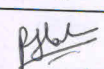
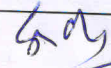

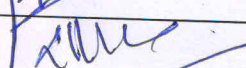
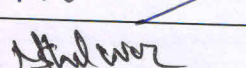
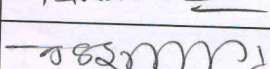
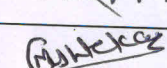
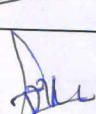


College Development Committee Meeting Academic Year 2017-18
