- 4. To conduct One-day workshop for students on "study-success-without-tension"
- 5. To Guide teachers and parents through occasional meetings, seminars and workshops
- 6. To conduct the "Personality Development Workshop" for the Teenagers & Youths between 15 and 28 years
- 7. To promote students for the 3 days 'Yauwan Kranti' camp (Age 15 to 21 yrs.) with emphasis on capability, leadership, entrepreneurship and management
- 8. To conduct 'Yashsafalya' yojana i.e. plan for success program and seminar for mind development and improving in studying methods for students
- 9. To Plan an Educational trip / Study tour / General visit to the Manashakti Research Centre, Lonavla with pre-determined schedule
- 10. Some collaborative events may be organised in the areas of common interest of both the institutes and selected persons of both the institutes may be allowed to participate in the events.
- 11. The financial aspects of any of the above activities will be negotiated separately and is subject to change as per mutual agreement.
